- 1001A EMPLOYEE SAFETY ORIENTATION (English or Spanish) (14 min.) \$99.95**
Meets OSHA requirements for training all employees who are exposed to "general hazards." Includes basic requirements, electrical, mechanical, back injury prevention, fire prevention, fire protection, personal protective equipment, and more. This video is also found in most all other categories, being somewhat modified for the category in which it is found.
- 1002A HAZARD COMMUNICATIONS (English or Spanish) (18 min.) \$ 99.95**
Meets OSHA requirements for training employees who use chemicals/hazardous materials in the workplace. Describes material safety data sheets (MSDS), labeling, and basic safety when using these materials.
- 1003A HAZARD COMMUNICATIONS -YOUR RIGHT TO KNOW (English or Spanish) (13 min.) \$99.95**
Program includes chemical spills, and reinforces the information required for training employees in MSDS and basic hazard communications. This video is also found in other categories as: 2002a, 5002a, 9011a, 17000a, 5-1015, being somewhat modified for the category in which it is found.
- 1004A OSHA'S HAZARDOUS ENERGY SOURCE (LOCKOUT/TAGOUT) (English or Spanish) (10 min.) \$99.95**
This is a great training tool for "affected" and "authorized" employees in lockout/tagout procedures. This program is also found as 15006a, being somewhat modified for the category in which it is found.
- 1005A WORKPLACE SAFETY INSPECTION CHECKLIST (English) (11 min.) \$99.95**
Overview of what workplace inspections are all about, how to complete inspection forms, and basics relating to unsafe conditions in any type of workplace.
- 1006A SB-198 CALIFORNIA'S SAFETY LAW (English or Spanish) (17 min.) \$99.95**
California passed a law in January 1990 outlining new requirements and standards for safety program development and implementation. Although the law only applies to California businesses, employers in other states should review it. It contains excellent information relating to safety program development, documentation and enforcement efforts. - 1007A OSHA RECORDKEEPING / INSURANCE PAPERWORK (English) (13 min.) \$99.95**

Designed for supervisors and middle management. This tape explains how supervisors are the keys to any program and how to provide safety leadership in a manufacturing environment.
